## About the James E. Flynn Scholarship Program

*Every year, the credit union awards \$7,000 in scholarships in the following ways:*

- FOUR (4) \$500 Elementary Scholarships for students in Kindergarten through 8<sup>th</sup> grade.
- FIVE (5) \$1,000 High School Scholarships for students in 9<sup>th</sup> through 12<sup>th</sup> grade.

The scholarships will be awarded by a random drawing. All scholarship funds will be paid directly to the school listed on the application on behalf of the child. All applicants must meet the following qualifications:

- Applicant must be an active member of Unity Catholic Federal Credit Union at the time the Scholarship Application is submitted.
- Applicants must be attending a Catholic school (Kindergarten–12<sup>th</sup>).
- Limit one Scholarship Application per Student.
- Limit one Student per Application.

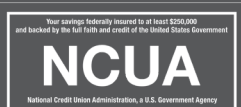
